CHARTER CHALLENGE: Emergency Management and Civil Protection and Promotion Act

As most of you are probably aware the Ontario Government issued an Emergency Order last spring that gives special privileges to the employer that include but are not limited to: scheduling, hours of work, redeployment of work, health care workers no longer are able to work in 2 workplaces related to Healthcare.

HOPE Local 2220 has filed a Challenge under the Charter of Rights stating that the current practices that Employer's are implementing are unfair, unreasonable and are violation of your rights under the Charter of Rights and Freedoms. As new information is available in this process we will be sharing with all of you.

HOPE IS FIGHTING FOR YOU!

Due to Public Health restrictions your union representatives are still unable to come into the buildings. <u>Please know we are working</u> <u>diligently for you and your rights to be upheld along with your</u> <u>collective agreement being upheld by your Employer.</u>
